Under provision IV "contractor qualifications and duties" Item C "Qualified Bidder's List" of potential future responsive bidders; to keep the list current; and to gather enough qualified sources to ensure proper competition.

Therefore the Bad River Housing Authority seeks small to medium contractors OR businesses with professional and qualified experience and expertise in plumbing, HVAC, flooring, electrical, roofing, concrete work, and/or any other general contracting activities, suppliers and services. Upon qualifying and being certified by the Board of Commissioners, each contractor or business on the list may be called upon to submit small bids for future projects that are under \$100,000.00.

Your business must be:

- Bondable
- Able to provide valid proof of workman's compensation or its equivalent
- Proof of insurance
- Able to guarantee workmanship
- Able to provide proof of Indian Preference (if claiming)
- Able to provide the necessary professional licenses
