- Demolish and and haul to landfill 2 abandoned structures (small house and guest house) and everything contained within them, located at 7043 W East North Drive, Hurley WI
 - o Small shack attached to guest house and open structure adjacent will be saved
- Disconnect and cap water/sewer pipes
- Disconnect and cap electrical lines
- General site clean up of old farm debris loose and in piles within approximately 100 yards of the house
- Site should be left safe and obstacle-free such that they pose no risk to people attending future public events

Proposals are required to contain the following information: Total cost for the project for: labor, equipment, and dump fees for the job.

The Bad River Band of Lake Superior Tribe of Chippewa Indians is a federally recognized Indian Tribe organized under Section 16 of the Indian Reorganization Act of 1934, U.S.C. Section 476. This entitles the Tribe to government pricing and exempts the Tribe from state sales and use taxes and from federal excise taxes. Therefore, price quotations should not include such taxes.

This Request for Proposals is open to all qualified, responsive bidders. Indian Preference will apply in the selection process in accordance with the Tribal Employment Rights Ordinance (TERO) or the Indian Preference Act of 1934 (Title 25, USC, Section 47), based on funding source requirements. Firms or persons applying for Indian preference must provide evidence in its proposal of 51% or more Indian ownership. In addition, the firm or person must provide evidence of structure, management and financing affecting the Indian character of the firm. Documentation of and compliance with Indian Preference must accompany the proposal.


